APPEAL by Trustees of the Divinity Hostel, of Braemor Park, Dublin against the decision made on the 11th day of May, 1978 by the Right Honourable the Lord Mayor Aldermen and Burgesses of Dublin deciding to refuse an outline permission for the erection of five detached dwellinghouses on a site at Dodder Road Lower, Rathgar, Dublin:

DECISION: Pursuant to the Local Government (Planning and Development) Acts, 1963 and 1976, outline permission is hereby refused for the erection of the said dwellinghouses for the reason set out in the Schedule hereto.

SCHEDULE

It is an objective of the Dublin Corporation as expressed in the Dublin City Davelopment Plan. 1971 to secure the reservation as open space of lands abutting the River Dodder. This site while separated from the river by Dodder Road Lower is an integral part of the river valley and the proposed development would take from the present open character of the area, would interfere with views and prespects which are regarded as being of special amenity value and would inhibit the satisfactory achievement of the Corporation's objective.
