With reference to your planning application received here on the 17th October 1970 in connection with the above, I wish to inform you that before your application can be considered under the Local Government (Planning and Development) Acts, 1963 and 1976 the following additional information must be submitted in quadruplicate:-

1. Further information is required which would provide for:-
 - (a) Details of the applicants specific proposals for the provision of an adequate site surfacing which would satisfactorily accommodate the proposed septic tank drainage system and also related to the site which forms part of the lands which were the subject of the grant of outline permission on appeal for the erection of 3 dwellinghouses by the Minister for Local Government dated 23/12/69. A 272
 - (b) The location of the existing dwellinghouse at the north and south sides of the site now proposed together with the locations of their respective septic tanks.
