With reference to your planning application received here on 21st September, 1978, in connection with the above, I wish to inform you that before the application can be considered under the Local Government (Planning and Development) Acts, 1963 and 1976, the following additional information must be submitted in quadruplicate:-

1. Further information is required which should provide for the following:-
  - (a) A correct and detailed site location plan clearly showing the advertising hoarding and its relation to the existing Shepperton Shopping Development.
  - (b) Full details of the hoarding structure, including its height above ground level.
  - (c) Full details of all the advertising matters displayed.
  - (d) A further public notice for retention to be published and evidence of this to be submitted in the following terms:-  
"CO. DUBLIN: Temporary planning permission for retention of advertising hoarding beside Trendy Fashions at Main Street, Tallaght, for Regan Advertising Limited".
  - (e) Evidence that the applicant has a sufficient estate or interest or the permission of a person with such an estate or interest in the site to carry out the proposed development.
