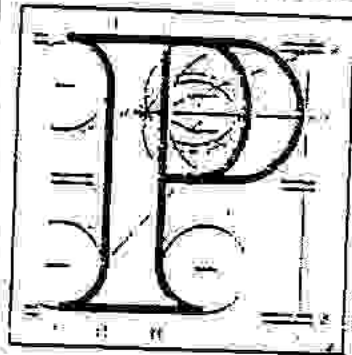

It is an objective of the Planning Authority as expressed in the Development Plan that the area in which this site is located be reserved to provide for the further development of agriculture. The intensification of commercial use of this site would be incompatible with this objective and militate against the preservation of the rural environment of the area.

The proposed development would contravene materially a condition attached to an existing permission viz. Condition No. 2 of Outline Permission granted on appeal by the Minister by Order dated the 23rd September 1971 which provided that the area into which it is proposed to extend the premises should be used for display and storage.
