LOCAL GOVERNMENT (PLANNING AND DEVELOPMENT) ACTS, 1963 TO 1990

WHEREAS

on the 6th day of December, 1978 Anom Engineering Limited care of Jordan and Partners of Main Street, Celbridge, County Kildare appealed to An Bord Pleanála against the decision made on the 10th day of November, 1978 by the Council of the County of Dublin to refuse permission for the erection of a single story industrial structure with ancillary offices at Ashfield, Naas Road, County Dublin :

AND WHEREAS


