A Chara,

With reference to your planning application received here on 8th August, 1978, in connection with the above, I wish to inform you that before the application can be considered under the Local Government (Planning and Development) Acts, 1963 and 1976, the following additional information must be submitted in quadruplicate:-

1. Outline permission for a bungalow on this site was granted on the understanding that the applicant was marrying a local girl whose parents reside in a house adjoining the site and who wished to reside close to her parents. In view of the grounds for granting outline permission a statement is required as to the precise status of the applicant, who was the architect in connection with the preparation of plans for submission of the application for outline permission.
2. Clarification as to whether the party to whom outline permission was granted would be prepared to enter into an agreement under Section 38, of the Local Government (Planning and Development) Act, 1963, restricting the use of the proposed bungalow to the applicant for outline permission.
