In pursuance of its functions under the above mentioned Acts the Dublin County Council, being the Planning Authority for the County Health District of Dublin, did by order, P/ **4006** dated **28/9/78.** decide to refuse:

For **proposed entry and roadway and a 60 ton weighbridge at Clondalkin Paper Mills Limited, Clondalkin, Co. Dublin,**
for the following reasons:

1. The proposed development would endanger public safety by reason of traffic hazard because it would generate turning movements of very long vehicles on the very heavily trafficked Clondalkin to Lucan Road at a point which is most unsuitable, being deficient in vision splays due to the curve on the road. The situation is further worsened because the proposed entrance is within 200-ft. of the recently constructed junction of the Mangor - Fox and Geese Road with the Clondalkin/Lucan Road.
2. The proposal would tend to create serious traffic congestion as the carriageway is only wide enough to permit two single lanes of traffic and any right turning movements would completely block one lane.

NOTE:- The applicant is advised to consult with the Roads Engineer with a view to locating a suitable point of access for the entrance and weighbridge.

When an appeal has been duly made and has not been withdrawn An Bord Pleanala will determine the application for permission as if it had been made to them in the first instance.
