Local Government (Planning and Development) Acts, 1963 and 1976,
the following additional information must be submitted in
quadruplicate:-

1. Further information is required with regard to:

(a) Specific details of the proposed works together with
clear information with regard to revised access facilities to
the existing adjoining dwellinghouses. The consent of the
adjoining affected property owners should be provided.

(b) Specific information with regard to the programme of the
proposed works and the applicant's proposals for re-routing
sign posting. The applicant must also indicate the
responsibility for the carrying out of the proposed works.

to this development.
