APPEAL by Thomas Healy of 19, Myrtle Park, Dun Laoghaire, County Dublin, against the decision made on the lith day of February, 1978, by the Council of the County of Dublin deciding to refuse to grant an outline permission for the erection of a bungalow on a site at Slievethoul, Brittas:

DECISION:

Pursuant to the Local Covernment (Planning and Development) Acts, 1963 and 1976, outline permission is hereby refused for the erection of the said house for the reasons set out in the Schedule hereto.

SCHEDULE

- 1. The site is in the Dublin Mountain zone in an area designated in the county development plan as one of high scenic amenity. It is the policy of the planning authority that any development in this area not directly related to its amenity potential or its use for agriculture, mountain or hill farming should be prohibited. This policy is considered reasonable and the proposed development would be in conflict with it and seriously injurious to the visual amenities of the area.
- 2. The site is located in an area served by an extremely substandard road network and the generation of additional traffic turning movements by the proposed development on this road network would endanger public safety by reason of traffic hazard.
