In pursuance of its functions under the above mentioned Act the Dublin County Council, being the Planning Authority for the County Health District of Dublin, did by order P/265/78 ..... dated 31st January 1978..... refuse:

for Proposed change of house type at sites 9-13 Castleknock Park Estate, .....

Castleknock, Co. Dublin, .....

for the following reasons:

1. The proposed houses on sites 9 to 11, inclusive, would be contrary to the proper planning and development of the area, as they do not provide for the minimum rear garden depths of 35-ft as required by County Development Plan. The development, as proposed, would not provide for adequate privacy and, consequently would result in a loss of amenity to both the future occupants of proposed houses and occupants of houses on sites 1, 2 and 3. It is considered that the depths of the rear gardens on sites 9 to 11 are at too great a variance with development plan standards, as to make the development substandard, and result in overhadowing of houses on sites 1 to 3.

NOTE: An appeal against the decision may be made to the Minister by the applicant within one month from the date of receipt by the applicant of this notification or by any other person within twenty-one days of the date of the decision. The appeal shall be in writing and shall state the subject matter of the appeal and grounds of the appeal and should be addressed to the Secretary, (Planning Appeals Section), Department of Local Government, Custom House, Dublin 1. When an appeal has been duly made and has not been withdrawn the Minister for Local Government will determine the application for permission as if it had been made to him in the first instance.
