That details relating to layout, siting, height, design and external appearance of the proposed building and means of access thereto shall be submitted to and approved by the Planning Authority before any works are begun. 2. That a financial contribution to be determined by the Planning Authority on submission of detailed plans for approval shall be paid by the applicant to the Dublin County Council towards the cost of provision of public services in the area of the proposed development and which facilitate this development: this contribution to be paid before the commencement of development on the site. 3. That the water supply and drainage arrangements including the design and location and satisfactory operation of the septic tank and disposal arrangements be in accordance with the requirements of the County Council. The applicant must discuss and agree these matters with the Health Inspector's Department and Dublin Corporation Waterworks Department, before any constructional work takes place.	1. In the interest of the proper planning and development of the area. 2. The provision of such services in the area by the Council will facilitate the proposed development. It is considered reasonable that the developer should contribute towards the cost of providing the services. 3. In order to comply with the Sanitary Services Acts, 1878 - 1964.
