With reference to your planning application received on the 23rd November, 1977, in connection with the above, I wish to inform you that before the application can be considered under the Local Government (Planning and Development) Act, 1963, the following information must be submitted in quadruplicate:-

1. The applicant must submit further plans to a scale of 1:100, which clearly show the following:-
 - (a) site boundaries;
 - (b) proposed vehicle access and carparking provisions;
N.B. Access must be from Bolbrook Estate and not from the by-pass.
 - (c) location of existing and proposed roads adjoining the site;
 - (d) proposed landscaping provision.
2. The applicant is required to submit further plans of the building showing proposed accommodation, sanitary facilities etc. and elevations showing proposed finishes.
