DECISION:

Pursuant to the Local Government (Planning and Development) Acts, 1963 and 1976, outline permission is hereby refused for the erection of the said house for the reasons set out in the Schedule hereto.

SCHEDULE

- It is an objective of the planning authority, as expressed in the County Development Plan, to reserve the area in which the site is located for the further development of agriculture. This objective is considered reasonable and the proposed development would be in conflict with it and would militate against the preservation of the rural environment.
- 2. It is considered that ribbon development on a minor rural road as proposed would be contrary to the proper planning and development of the area and would lead to demands for the uneconomic provision of public services in the general area.
- The proposed development would be prejudicial to the safe operation of Casement Aerodrome.
