for the following reasons:

- The site is located in an area zoned to provide for the further development of agriculture in the Development Plan. The commercial development proposed in a rural area where public piped water or sewerage services are not available would materially contravene the above objective, would be contrary to the proper planning and development of the area and would seriously injure the amenities of the area.
- Public piped water supply mor sewerage facilities are not available to serve the proposed development.
- 3. The proposed development would be premature by reason of the said existing deficiency in the provision of water and sewerage facilities and the period within which such deficiency may reasonably be expected to be made good.
- 4. The proposed development with access from the Maas Rodd would endanger public safety by reason of treffic hazard due to the generation of additional traffic turning movements on the heavily trafficked and high speed national primary route.
- N.B. By Order No. HS/210/27mdated 8/12/27mpermiseion for change of use of the cottage was refused under the 1969 Housing Act accordingly under Section 10 (w) of that Act Section 26 (4) (a) of the act of 1963 shall not apply in relation to the cottage.
