APPEAL by Patrick Bagnall, of Killinimy House, Firhouse Road, Tallaght, County Dublin, against the decision made on the lith day of December, 1977, by the Council of the County of Dublin deciding to refuse to grant an outline permission for the erection of a petrol filling station on a site at Killinimny, Firhouse Road, Tallaght:

DECISION:

Pursuant to the Local Government (Planning and Development) Acts, 1963 and 1976, outline permission is hereby refused for the erection of the said petrol filling station for the reasons set out in the Schedule hereto.

SCHEDULE

- 1. The site is located in the Dodder Valley in an area designated as one of high amenity in the development plan which it is the policy of the planning authority, as expressed in the plan, to preserve. This policy is considered reasonable and the proposed development would be in conflict with it and seriously injurious to the amenities of the area.
- 2. The proposed development would endanger public safety by reason of traffic hazard due to the additional traffic turning movements which would be generated by a commercial development of the type proposed on the narrow, peorly aligned and heavily-trafficked road fronting the site.
- 3. Part of the site is likely to be affected by proposals for the improvement of Firhouse Road.
