### Reasons for Conditions

1. Subject to the conditions of this permission the development to be carried out and completed strictly in accordance with the plans and specifications lodged with the application.

2. That the structure shall be removed on or before 31/10/1982, unless before that date permission for its retention is granted by the Planning Authority or by An Bord Pleanála on appeal.

3. That the drainage arrangements including the disposal of surface water be in accordance with the requirements of the County Council. The applicant must consult with the Public Health Superintendent with regard to these matters.

1. To ensure that the development shall be in accordance with the permission and that effective control be maintained.

2. To enable the effect of the development on the amenities of the area to be reviewed, having regard to the conditions then obtaining.

3. In order to comply with the Sanitary Services Acts, 1970-1964.
