1. To the conditions of this permission the development to be carried out and completed strictly in accordance with the plans and specifications submitted with the application.
2. Development commences approval under the Act. Eye-lens to be obtained, and all conditions of approval to be observed in the development.
3. The proposed house be used as a single dwelling.
4. A financial contribution in the sum of £100.00 to be made by the proposer to the Dublin County Council.
