DECISION: Persuant to the Local Covernment (Planning and Development) Acts, 1963 and 1976, outline permission is hereby refused for the erection of the said shop for the reasons set out in the Schedule hereto.

#### SCHEDULE

- 1. It is an objective of the planning antiority as expressed in the County Development Plan, to preserve the area of which the site forms part as amenity open space. This objective is considered resourchle and the proposed development would be in conflict with it.
- 2. The proposed development would endenger public safety by reason of traffic hazard because the site is located at a junction between two bends along a substandard and heavily-trafficked road and the additional traffic povements generated by the development would interfere with the safety and free flow of traffic on the road.
