APPEAL by Lillian McCormick, of Glenanareen, Brittas, County Dublin, against the decision made on the 29th day of September, 1977, by the Council of the County of Dublin deciding to refuse to grant an outline permission for the erection of a bungalow on a site at Glenanareen/Crockaunadreenzgh, Brittas:

DECISION: Pursuant to the Local Government (Planning and Development) Acta, 1963 and 1976, outline permission is hereby refused for the erection of the said bungalow for the reasons set out in the Schedule hereto.

SCHEDULE

- 1. The site is located in the Dublin Mountain zone, in an area of high scenic value which it is an objective of the planning authority, as expressed in the development plan, to conserve. This objective is considered reasonable and the proposed development would be in conflict with it and seriously injurious to the amenities of the area.
- 2. By order dated 27th April, 1967, the Minister for Local Government granted outline permission for the erection of a house on land to the north of the site (Planning Register Reference Lumber: 1168) and by order dated 8th October, 1971 the planning authority decided to grant permission for the erection of the said house (Planning Register Reference Number: D.1679). A condition att ched to each of the said orders required that certain land be starilized from future building development. The site forms part of the said land and the proposed development would accordingly materially contravene the conditions in question.
