APPLICANT: Sitecast (Ireland) Ltd.

In pursuance of its functions under the above mentioned Act the Dublin County Council, being the Planning Authority for the County Health District of Dublin, did by order P/3012/77... dated 23rd August 1977... decide to refuse:

~~OUTLINE PERMISSION~~ PERMISSION; ~~APPROVAL~~

for Proposed painted sign on roof at Unit Ref. A40 Sitecast Industrial Estate, Ballyfermot Road, Dublin 10.
for the following reasons:

1. It is the opinion of the Planning Authority that such large signs on the roof of buildings are visually objectionable and contrary to the proper planning and development of the area. The size of the sign with letters 20-ft. high and sign width of 170-ft. would be out of scale and proportion in this area. It could lead to a proliferation of such signs in this area and would detract from the general appearance and character of the industrial estate.

NOTE: An appeal against the decision may be made to the Minister by the applicant within one month from the date of receipt by the applicant of this notification or by any other person within twenty-one days of the date of the decision. The appeal shall be in writing and shall state the subject matter of the appeal and grounds of the appeal and should be addressed to the Secretary, (Planning Appeals Section), Department of Local Government, Custom House, Dublin 1. When an appeal has been duly made and has not been withdrawn the Minister for Local Government will determine the application for permission as if it had been made to him in the first instance.
