### AN BORD PLEANALA

#### LOCAL GOVERNMENT (PLANNING AND DEVELOPMENT) ACTS, 1963 AND 1976

#### Planning Register Reference Number: M.1461

APPEAL by Westside Taverns Limited, of 45, Northumberland Road, Dublin, against the decision made on the 9th day of August, 1977 by the Council of the County of Dublin deciding to grant subject to conditions a permission for the provision of an additional carparking area on land adjoining the "Foxes Covert", Main Street, Tallaght in accordance with plans and particulars lodged with the said Council:

DECISION: Pursuant to the Local Government (Planning and Development) Acts, 1963 and 1976, it is hereby decided, for the reasons set out in the First Schedule hereto, to grant permission for the provision of the said additional car parking area in accordance with the said plans and particulars, subject to the condition specified in column 1 of the Second Schedule hereto, the reason for the imposition of the said condition being as set out in column 2 of the said Second Schedule and the said permission is hereby granted subject to the said condition.

#### FIRST SCHEDULE

The site is located in an area which the planning authority consider should be developed in a comprehensive manner. This policy is considered reasonable but having regard to the length of time which will be required to secure its implementation it is not considered that the use of the site as a car-park for the period specified in the Second Schedule hereto would be in conflict with it or otherwise contrary to the proper planning and development of the area.

The use of the site as a carpark shall be discontinued on the expiration of a period of three years from the date of this order unless by that time permission for its retention for a further period has been granted by To allow the planning authority to review the situation in the light of circumstances then prevailing having regard to their objectives for the area.
