- 1. The proposed development would result in an unnecessary and undesirable reduction in the amount of public open space available to the residents of Glenvara Park and would consequently be seriously injurious to the residential amenities of the area.

The proposed development would contravene materially condition number 2 attached to an existing permission granted by the planning authority consequent on a decision made on the 5th day of April. 1976 (Planning Register Reference Number H2297) which stipulated that lands including portion of the site the subject of this appeal be reserved for use as public open space. This condition is considered reasonable.
