In pursuance of its functions under the above mentioned Act the Dublin County Council, being the Planning Authority for the County Health District of Dublin, did by order P/2378/77 dated 7th July, 1977.

decide to refuse:

for Proposed ^{extension of} dwellinghouse at Nass Road, Rathcoole.

for the following reasons:

1. The retention of the dwelling with the existing access onto the Nass Road dual carriageway National Primary Route would endanger public safety by reason of traffic hazard because of the generation of vehicle turning movements to and from this heavily trafficked high speed main road.

N.B. The applicant is advised to examine the feasibility of providing an alternative safe access to the site.

When an appeal has been duly made and has not been withdrawn the Minister for Local Government will determine the application for permission as if it had been made to him in the first instance.
