## LOCAL GOVERNMENT (PLANNING AND DEVELOPMENT) ACTS, 1963 AND 1976

AFPEAL by Hillside Developments, of 7, Laurel Park, Clondalkin, County Dublin, against the decision made on the 1st day of July, 1977, by the Council of the County of Dublin deciding to refuse to grant an outline permission for the erection of six bungalows on sites at Redgap, Rathcoole:

DECISION: Fursuant to the Local Government (Planning and Development) Acts, 1963 and 1976, outline permission is hereby refused for the erection of the said six bungalows for the reasons set out in the Schedule hereto.

#### SCHEDULE

- 1. It is an objective of the planning authority, as expressed in the development plan, to reserve the area in which the site is located for the further development of agriculture. This objective is considered reasonable and the proposed housing development would be in conflict with it and would militate against the preservation of the rural environment.
- 2. The site is located in an area served by an extremely substandard road network and the additional traffic movements which would be generated by the proposed development on this insdequate road network would endanger public safety by reason of traffic hazard.
