With reference to your Planning Application received here on the 28th April, 1977, in connection with the above, I wish to inform you that before the application can be considered under the Local Government (Planning and Development) Acts, 1963 and 1976, the following additional information must be submitted in quadruplicate:-

1. A trial hole 6'-6" deep should be opened on the site to establish if the soil is suitable for the disposal of septic tank effluent.
2. A block plan of 1:500 should be submitted showing the road reservation to the North East as it exists on the ground with the house located a minimum of 50-ft., from this existing fence.
3. As the site of the proposed development is located in an area with the zoning objective to provide for the further development of agriculture, details to be submitted as to the applicants need for a house in this area.
