1. Further information is required which should provide for:
  - (a) A corrected estate layout plan properly related to the plans which were submitted to and approved by the County Council and the subject of a decision to grant permission by Order No: P/3157/73, dated 26th October, 1973, (Reg. F. 1201).
  - (b) The corrected location of the existing drainage system servicing this portion of the estate and its correct relationship to the dwellinghouses located at the west side of Willington Crescent.

Note: The applicant must consult with the County Council before submitting further information required.
