APPEAL by John Kelly, of 41, St. Marys Park, Saggart, County Dublin, against the decision made on the 24th day of May, 1977, by the Council of the County of Dublin deciding to refuse to grant an outline permission for the erection of a bungalow on a site at Redgap, Rathcoole:

DECISION: Pursuant to the Local Government (Planning and Development) Acts, 1963 and 1976, outline permission is hereby refused for the erection of the said bungalow for the reason set out in the Schedule hereto.

SCHEDULE

It is an objective of the planning authority, as expressed in the development plan, to reserve the area in which the site is located for the further development of agriculture.
