This objective is considered reasonable, and the proposed development would be in conflict with it and would militate against the preservation of the rural environment.
- 2. The proposed development would constitute undesirable ribbon development on a narrow and substandard road and the traffic movements generated by it would endanger public safety by reason of traffic hazard and obstruction of road users.
