APPEAL by Viscount Securities Limited, of 13, Merrion Square, Dublin, against the decision made on the 3rd day of May, 1977, by the Council of the County of Dublin deciding to refuse to grant an outline permission for residential development on a site at Woodpark and Carrigwood Estates, Ballycragh, in accordance with plans and particulars lodged with the said Council:

DECISION: Pursuant to the Local Government (Planning and Development) Acts, 1963 and 1976, it is hereby decided, for the reasons set out in the First Schedule hereto, to grant outline permission for residential development on the said site in accordance with the said plans and particulars, subject to the conditions specified in column 1 of the Second Schedule hereto, the reasons for the imposition of the said conditions being as set out in column 2 of the said Second Schedule and the said outline permission is hereby granted subject to the said conditions.

FIRST SCHEDULE

It is considered that the proposed development, would accord with the pattern of existing development in the vicinity, would not prejudice the planning authority's road proposals for the area or be otherwise contrary to its proper planning and development.

The plans and particulars to be submitted to the planning authority for approval shall provide for vehicular access to the site to be from the distributor road to the north and the omission of vehicular access to Ballycullen road.</p> <p>2. The developers shall pay a sum of money to the Dublin County Council as a contribution towards the said Council's expenditure on the provision of a public water supply and piped sewerage facilities in the area. The amount to be paid and the time and method of payment shall be agreed between the developers and the said Council before the development is commenced or, failing agreement, shall be as determined by An Bord Pleanála.</p>	<p>1. In the interests of traffic safety.</p> <p>2. The provision of such services in the area by the Council will facilitate the proposed development. It is considered reasonable that the developers should contribute towards the cost of providing the services.</p>
