In pursuance of its functions under the above mentioned Act the Dublin County Council, being the Planning Authority for the County Health District of Dublin, did by order P/1404/77, dated 3rd May, 1977, decide to refuse:

~~ROUTINE PERMISSION~~ PERMISSION; ~~APPROVAL~~

for proposed houses on sites 352, 353, and 1511 to 1522, Group 3,

.....Kilnamanagh, Tallaght,.....
for the following reasons:

1. The proposed development on site Nos. 1511-1522, located on previously approved open space, would contravene materially conditions attached to existing permissions, i.e. Condition No. 13 of the grant of permission by the Minister for Local Government by order, dated 5/3/73 and condition No. 3 of decision to grant permission by order P/3021/76, dated 15/9/76, (K.1744).
2. The proposed development on sites No. 352/353 would contravene materially a condition attached to an existing permission, i.e. Condition No. 4 of decision to grant permission by order No. P/3352/73, dated 13/11/73 (F.2002) as this condition specifically required the omission of sites 352 and 353 from the development.

NOTE: An appeal against the decision may be made to the Minister by the applicant within one month from the date of receipt by the applicant of this notification or by any other person within twenty-one days of the date of the decision. The appeal shall be in writing and shall state the subject matter of the appeal and grounds of the appeal and should be addressed to the Secretary, (Planning Appeals Section), Department of Local Government, Custom House, Dublin 1. When an appeal has been duly made and has not been withdrawn the Minister for Local Government will determine the application for permission as if it had been made to him in the first instance.
