I. The site is located in an area zon	ned to provide for the further	

- The site is located in an area zoned to provide for the further development of agriculture in the Development Plan. The development proposed would contravene materially this objective, would be contrary to the proper planning and development of the area and would be seriously injurious to the amenities of the area.
- 2. The site proposed forms a small part of the lands which were the subject of a special permission for a bungalow and outhousing order No.TP/983/55 dated 1/12/55, and decisions to grant permission for sevised house types by Order Nos P/236/72, dated 31/12/72 (D.1944), P/1433/72, dated 12/6/72 (E.890) and P/155/73 dated 18/1/73 (E.2158) and the development proposed would thus be at variance with these permissions for the erection of a single bungalow on the entire site and would be contrary to the proper planning and development of the area.
- Bublic piped sewerage facilities are not available to serve the proposed development.
- 4. The proposed development would be premature by reason of the said existing deficiency in the provision of sewerage facilities and the period within which such deficiency may reasonably be expected to be made good.
