A. Chara,

With reference to your planning application received here on the 28th January, 1977, in connection with the above, I wish to inform you that before your application can be considered under the Local Government (Planning and Development) Act, 1963, the following additional information must be submitted in quadruplicate:-

1. Evidence of suitability of the soil conditions for septic tank drainage and of the availability of an adequate source of potable water.
2. Revised plans must be submitted which show the position of the proposed house, source of potable water supply and septic tank as agreed with the Health Inspector, and which show details of access to the site which would be acceptable to the County Council Roads Engineer.

N.B. The applicant should consult with the Health Inspector for the area and with the County Council's Roads Department before submitting additional information.
