A PERMISSION/APPROVAL has been granted for the development described below subject to the undermentioned conditions.  
**proposed dwellinghouse at Military Road, Woodtown, Co. Wick**

### Conditions

1. Subject to, the conditions of this permission the development to be carried out and completed strictly in accordance with the plans and specification lodged with the application.
2. Before development commences, approval under the Building Bye-laws to be obtained, and all conditions of that approval to be observed in the development.
3. That the proposed house be used as a single dwelling unit.
4. That a financial contribution in the sum of £100. be paid by the proposer to the Dublin County Council towards the cost of provision of public services in the area of the proposed development, and which facilitate this development, this contribution to be paid before the commencement of development on the site.
5. That the water supply and drainage arrangements, including the design, location and satisfactory arrangements for the disposal of septic tank effluent be in accordance with the requirements of the County Council. The applicant must consult with the Health Inspector's Department with regard to these matters. The applicant must consult with the Engineers with regard to satisfactory arrangements with regard to the surface water system proposed. No construction work is permitted within 15' of the existing County Council mains traversing the site. This main must be fully protected from damage at all times.
6. Details of the proposed access to the public road are to be fully discussed and agreed with the Roads Engineer. Adequate provision is to be made for entrance and adequate traffic visibility at the entrance.

### Reasons for Conditions

1. To ensure that the development shall be in accordance with the permission, and that effective control be maintained.
2. In order to comply with the Sanitary Services Acts, 1878-1964.
3. To prevent unauthorised development.
4. The provision of such services in the area by the Council will facilitate the proposed development. It is considered reasonable that the developer should contribute towards the cost of providing the services.
5. In order to comply with the Sanitary Services Acts, 1878-1964.
6. In the interest of public safety and avoidance of traffic hazard.
