APPEAL by Rafael Urbech, of 27 Ballytore Road, Dublin; against the decision made on the 12th day of October, 1978, by the Right Honourable, the Lord Mayor, Aldersen and Burgesses of Dublin, deciding to refuse to grant as outline permission for office development together with shops and light industry at 200 Rathfarnham Road, Dublin;

DECISION: Pursuant to the Local Government (Planning and Development) Acts, 1963 and 1976, outline permission is hereby refused for the said office development, shops and light industry for the reason set out in the Schedule hereto.

SCHEDULE

The site is located in an area zoned for residential use in the Dablin Davelopment Plan; 1971. This zoning is considered reasonable and the proposed office development, shops and light industry would be in material coefficit therewith and would be seriously injurious to the residential amenities of the area.
