With reference to your Planning Application received here on the 16th November, 1976, in connection with the above, I wish to inform you that before the application can be considered under the Local Government (Planning and Development) Act, 1963, the following additional information must be submitted in quadruplicate:-

1. The applicant is requested to submit details of how it is proposed to provide adequate water supply for the development.
N.B. The applicant should consult with the Sanitary Services Department before submission of these details.
2. The applicant is requested to submit revised plans omitting sites 436 to 441, inclusive to allow for provision of local shopping facilities and resiting house No. 225, on Dr. No. 121/1/1001, so as to allow a minimum of 35' between the rear of the house and the boundary of site 176.
