A Chara,

With reference to your planning application received here on the 10th November 1976, in connection with the above, I wish to inform you that before your application can be considered under the Local Government (Planning and Development) Act, 1963, the following additional information must be submitted in quadruplicate:

- (1) Details of existing and proposed surface water and foul sewer system to be submitted. The "fall" of the floor to the existing drain is inadequate. Applicant should submit details of the fall of the floor of the extension.
- (2) A block plan is required showing the entire slaughter house boundary wall, yard, lairage, killing, hanging and cooling area, cold room, deep freeze and facilities for disposal of manure and green offal.
- (3) Details to be supplied by the owner as to the proposed maximum kill (daily and weekly) of sheep and cattle.
