APPEAL by McGoff Holdings Limited, of Woodlands, Nazz, County Kildare, against the decision made on the 7th day of October, 1978, by the Council of the County of Dublin deciding to refuse an outline permission for office and residential development (Scheme 2) on a site at St. Brigid's/Brideswell Commons, New Road, Clondalkin, County Dublin:

DECISION: Pursuant to the Local Government (Planning and Development) Acts, 1983 and 1976, outline permission is hereby refused for the said development, for the reasons set out in the Schedule hereto.

#### SCHEDULE

- i. The proposed office development would be located on the fringe of the Clondalkin/Lucan new urban unit, relatively remote from any area zoned for such development within the unit. It is considered that such sporadically-located development would be contrary to the proper planning and development of the area because it would inhibit the provision of properly planned commercial facilities in the new town centre.
- 2. The site is likely to be seriously affected by major new read works in the area and the proposed development does not provide for the reservation of land expected to be required for such works.
- 3. The proposed development would endanger public safety by reason of traffic hazard due to the inadequacy of the existing roads to accommodate the additional turning movements generated without causing excessive interference with and disruption of traffic flow.
