3. That the temporary changing rooms must be erected, or removed as when required, when the main comprehensive changing room arrangements are provided.	3. In the interests of amenity and the proper planning and development of the area.
4. That the requirements of the Chief Fire Officer be ascertained and adhered to in the development.	4. In the interests of public safety and avoidance of fire hazard.
5. That the specific location of the proposed structure be agreed with the Parks Superintendent.	5. In the interests of amenity and the proper planning and development of the area.
