- The proposed development which consists of a separate detached unit in the back garden of an existing Single family dwelling is contrary to the proper planning and development of the erea. It is located in an area where single family dwellings predominate. The proposed development contravenes the Council's zoning objective for the area i.s. "to preserve and improve residential amenity".
- The site boundary of the proposed development forms part of the reservation line for the proposed Palmeratown By-Pasa. The proposed development would contravene a building line on the proposed by-pass and occupants of such a unit would be subject to future excessive noise levels.
- 3. The proposed development would seriously injure the emenities and depreciate the value of property in the area. It is considered that the area of the proposed development should remain as emenity open space attaching to the existing dualling house.
