Conditions

1. That the development be carried out and completed strictly in accordance with the plans and specification lodged with the application save as is in the conditions hereunder otherwise required.
2. That conditions 2, 3, 4, 6, & 7 of Order No. P/3338/74, dated 14/10/74, be adhered to in respect of this development.
3. That the proposed structure Unit No. 14 shall be used for warehouse and ancillary purposes and that Unit No. 13, shall be used for factory warehouse and ancillary purposes as set out in the application, dated 18/6/75, and any proposed change of use shall be subject to the approval of the Planning Authority or the Minister for Local Government, on appeal. Retail sales and supermarket operations are not permitted.
4. That before development commences, Building Bye-laws approval shall be obtained and any conditions of such approval shall be observed in the development.
