for ..Proposed retention of garage conversion to shop at 23, Tibbadden Close,

for the following reasons:

1. The retention of this shop within the curtilage of an existing dwelling-house, on a recently constructed residential estate, would not be in accordance with the proper planning and development of the area and would seriously injure the amenities of the area.
2. The retention of this development for commercial purposes, without adequate off-street car parking access facilities and loading/unloading facilities would endanger public safety by reason of traffic hazard because of the undesirable additional commercial vehicular movements to and from the site on to the existing residential road network.

The appeal shall be in writing and shall state the subject matter of the appeal and grounds of the appeal and should be addressed to the Secretary, (Planning Appeals Section), Department of Local Government, Custom House, Dublin 1. When an appeal has been duly made and has not been withdrawn the Minister for Local Government will determine the application for permission as if it had been made to him in the first instance.
