With reference to your planning application received here on the 22nd March, 1976, in connection with the above I wish to inform you that before the application can be considered under the Local Government (Planning and Development) Act, 1963 the following additional information must be submitted in quadruplicate:-

- (1) Further plans are required which should clearly show -
 - (a) the area of land in acres in the applicant's ownership.
 - (b) the area of land in acres already sterilised in connection with the erection of dwellinghouses on the lands.
 - (c) satisfactory evidence that the proposed dwelling is for the applicant's own use.
 - (d) satisfactory evidence of soil suitability for septic tank drainage, together with satisfactory evidence that an adequate and potable water supply is available.
