Proposed retention of Social Club at 9th Lock Road, Clondalkin,
Co. Dublin.

Conditions

1. Subject to the conditions of this permission, that the development be carried out and completed strictly in accordance with the plans and specification lodged with the application.
2. The structure to be removed from the site prior to 1/1/1980 unless to that time permission for its retention for a further period shall have been granted by the Planning Authority or the Minister for Local Government.
3. The social club to be used solely for purposes ancillary to the existing industrial operations on the lands of C.S. Packaging Ltd. in the area.
4. That the club not be used for the sale of intoxicating liquor without a prior grant of permission from the Planning Authority or the Minister for Local Government on appeal.
5. That the following requirements of the Supervising Health Inspector Eastern Health Board be adhered to
 - (a) Numbers and sex of persons using the club in order to assess the suitability of toilet accommodation.
 - (b) Compliance with Food Hygiene Regulations 1950/71 and Control of Atmospheric Pollution Regulations 1973.

Reasons for Conditions

1. To ensure that the development shall be in accordance with the permission, and that effective control be maintained.
2. To enable the effect of its development on the area to be reviewed.
3. In the interest of the proper planning and development of the area.
4. In the interest of the proper planning and development of the area.
5. In order to comply with the Sanitary Services Acts, 1878-1964 and the control of Atmospheric Pollution Regulations 1970.
