AFFEAL by Parson Developers's Limited of 200 Enthfornbas Road, against the decision made on the 20th day of August, 1975, by the Hight Renourable the Lord Payer, Alderson and Burgesson of Dub'in deciding to refuse to grant permission for the change of use of a structure at 200 Tethfornbas Road, Dublin, from use as an office to use as a shop:

DECISION: Parsuant to subscation (5) of section 26 of the Local Government (Planning and Development) Act, 1965, permission is hereby refused for the said change of use of the said structure for the reasons set out in the Schedule berate.

SCHROULE

- L. The structure is located in an area somed for residential use in the Dublin Development Plan. This soming is considered reasonable and the proposed change of use from a simor non-conforming office use to use as a shop would result in a significant intensification of the commercialuse of the structure and would be seriously injurious to the residential assentties of the area.
- 2. There is no provision for off street loading and unloading facilities to serve the proposed shop and in the absence of such facilities the development would endanger public safety by reason of obstruction and traffic hazard on Eathfarnham Road.
