With reference to your Planning Application received here on the 3rd December, 1975, in connection with the above, I wish to inform you that before the application can be considered under the Local Government (Planning and Development) Act, 1963, the following additional information must be submitted in quadruplicate:-

1. Further plans are required which should provide for the following:-
 - (a) Details of the proposed uses and activities envisaged together with the operating times of these activities.
 - (b) Details of the anticipated vehicle movements to and from the Community Centre.
 - (c) Adequate and satisfactory evidence that the proposed uses will not adversely affect the amenities of the adjoining residential properties. The applicants are advised to ensure that the structure is adequately sound proofed and is provided with adequate and satisfactory fire hazard protection.
