With reference to your Planning Application received here on the 6th November, 1975, in connection with the above, I wish to inform you that before the application can be considered under the Local Government (Planning and Development) Act, 1963, the following additional information must be submitted in quadruplicate:

- 1. Further plans are required which should provide for the following:-
 - (a) Adequate and satisfactory evidence that the site proposed is suitable for septic tank drainage, with revised septic tank errangements together with any necessary trial holes required by the Health Inspector's Department.
 - (b) Satisfactory evidence is also required that an adequate and potable water supply is available. The applicant must consult with the Health Inspector's Department before submitting further plans.

Note: The applicant should discuss theme requirements with the Health Inspector's Department, 9, Rutland Place, Dublin, so that a satisfactory location for the proposed house septic tank and private water supply can be agreed before submitting revised plans.
