That the lighting of the panels be so controlled as not to cause excessive glare, <sup>or</sup> distraction to road users, or adjoining property owners, and that the hours of lighting shall not extend beyond the normal hours of lighting of the adjoining street lights.	4. 5. That the applicants indemnify the County Council against any claim made against the Authority as a result of the presence of the structure on public property.	5. In the interest of the proper planning and development of the area.
