In pursuance of its functions under the above mentioned Act the Dublin County Council, being the Planning Authority for the County Health District of Dublin, did by order P/2138/75 dated 17th July, 1975, decide to refuse:

for Proposed bus shelter at Palmerstown, at Ulster Bank.

for the following reasons:

1. It is the opinion of the Planning Authority that the bus shelter as proposed would interfere with the vision of traffic emerging from Mill Lane, thereby creating a traffic hazard.

Note: The applicant is advised that favourable consideration might be given to the bus shelter if it is located some 150-ft., west of Mill Lane.

NOTE: An appeal against the decision may be made to the Minister by the applicant within one month from the date of receipt by the applicant of this notification or by any other person within twenty-one days of the date of the decision. The appeal shall be in writing and shall state the subject matter of the appeal and grounds of the appeal and should be addressed to the Secretary, (Planning Appeals Section), Department of Local Government, Custom House, Dublin 1. When an appeal has been duly made and has not been withdrawn the Minister for Local Government will determine the application for permission as if it had been made to him in the first instance.
