- (1) The scale of the proposed development is considered excessive having regard to the likely shopping requirements for the area and would give rise to overloading of the road system with onsequent congestion and traffic hazard.
- (2) The proposal would bend to create serious traffic congestion due to generation of increased traffic turing movements and the location of the access in close proximity to a junction.
- (3) There are no public piped sewerage facilities available to serve the proposed development.
