<p>2. That the applicants indemnify the Corporation against any claims made against the authority as a result of the presence of the structure on a public footpath.</p>	<p>In the interest of public safety.</p>
<p>3. That the applicants make satisfactory arrangements for the maintenance, repair and upkeep of the structure.</p>	<p>In the interest of amenity and public safety.</p>
<p>4. That the applicants ^{accept} responsibility for the removal of the structure at their own expense, if such is necessary, for the purpose of widening, reconstruction or repair of the road or footpath or for the repair replacement or removal of any service installed in the public street.</p>	<p>In the interest of the proper planning and development of the area.</p>
<p>5.
